Application Package for the DBA Program (2026-2027)

Program Overview

Hitotsubashi ICS has offered since 2002 a doctoral degree program aimed at developing scholars who can serve as "one bridge" between the worlds of scholarship and practice. The Doctor of Business Administration (DBA) program is conducted in English at Hitotsubashi ICS's campus in Chiyoda-ku, Tokyo.

The DBA program places particular emphasis on business problem-solving and its practical implications, while providing a theoretical and scientific foundation that adds academic rigor to research. DBA candidates combine insights from their own business experience with new knowledge gained through a rigorous program of independent research and exposure to state-of-the-art ideas discussed at business schools. DBA candidates are required to produce distinctive, original output at the leading edge of applied management research. Successful DBA theses combine original theories and methods as well as offer practical relevance and insights that will influence how managers think about business issues.

The DBA program relies heavily on individual initiative. Each DBA candidate spends a minimum of three years designing and executing a research project under the academic supervision of Hitotsubashi ICS faculty. This work results in a thesis targeting publication as an academic paper or a research-oriented management book. DBA candidates are required to complete three mandatory courses (two required and one special lecture) and seminar, and can choose from among a range of elective courses as many as which support implementation of their research. A candidate's academic milestones in the program include A) successful defense of their thesis proposal at a hearing, and B) successful completion and defense of their doctoral thesis. DBA candidates are permitted to audit MBA courses with the approval of their advisor and the course instructor. During the program, there are opportunities to work as a research assistant (RA) or teaching assistant (TA) for their advisor or other faculty members.

Successful applicants to the DBA program must have two or more years of full-time work experience. While an MBA degree or other master's degree is generally required for admission, the Admissions Committee may grant waivers for exceptionally qualified applicants.

The types of qualified applicants Hitotsubashi ICS seeks to attract to its DBA program include:

(1) Professionals with a master's degree seeking an early career change into academia as a faculty member of a business school. As standards for academic performance continue to rise among hiring business schools, more rigorous academic training is required for full-time faculty positions. Hitotsubashi ICS strongly recommends that candidates seeking a career in academia enroll in the program full time and contact the school one or two years prior to applying to the DBA program. This course of action improves the likelihood of a full-time doctoral student securing funds from their first year via external research fellowships such as the Research Fellowship for Young Scientists of the Japan Society for the Promotion of Science (JSPS).

- (2) Faculty members and instructors at other business schools currently not holding a doctoral degree (e.g., *Jitsumuka-kyoin* at Japanese business schools) and seeking to develop their research, education and academic careers at a higher level as doctoral degree holder.
- (3) Experienced senior management practitioners who have already formulated clear research ideas through their own work experiences and are envisioning the DBA degree as an integrated part of their business careers.

DBA candidates must maintain residency in Japan while enrolled at Hitotsubashi ICS in order to participate in the program's courses and meetings with faculty members.

Professor Satoshi Akutsu is the DBA Program Director. Students may request any member of the DBA faculty to be their thesis advisor, contingent on obtaining approval from the DBA Program Committee and the faculty member concerned.

Admissions Policy

The DBA Program in School of International Corporate Strategy, Graduate School of Business Administration at Hitotsubashi University (hereafter referred to as the DBA Program) is designed for students who wish to engage in research or education in the fields of commerce and business administration as instructor, researcher, or practitioner in the future. Students must: (1) demonstrate genuine interests in the field of commerce and business administration through their professional experience, (2) be motivated to formulate and respond to their own research questions, (3) possess the literacy (in-depth academic knowledge in their discipline and high level of language competence) and clarity to start research project in the field of their choice, (4) possess a high level of research ethics to contribute to the sound development of social sciences, and (5) demonstrate a strong motivation to contribute to the development of academia and industry as a DBA holder.

In order to select our candidate, we evaluate the ability and motivation of candidate based on dossier which includes research plans, and by conducting interview to attest their clarity and research plans, in addition to TOEFL (exempted for native English speakers and those who have obtained a bachelor's degree or higher in an English language program) and GMAT or GRE scores. One important prerequisite for the admission is to have at least two years of professional experiences and a master's degree in a related field, such as an MBA, or equivalent experience and knowledge.

Application and Admissions Procedures

(1) Maximum number of students to be admitted for 2026

Four (4) students

(2) Qualification of applicants

- An MBA or other master's degree is required for admission. Applicants requesting an exemption must seek approval from the DBA Program Committee beforehand.
- Two or more years of full-time work experience, or approval for exemption from the DBA Program Committee.
- Applicants with no MBA or master's degree, or who have less than 2 years of full-time work experience who believe that they have equivalent professional experience must write beforehand to the Hitotsubashi ICS Admissions Office (ics-opencampus@ics.hub.hit-u.ac.jp) the intention for the pre-screening. Required documents for the pre-screening must be submitted to the Admissions Office by the following deadline.

Round 1 applicant: August 1, 2025; Round 2 applicant: January 23, 2026

- A good command of English, with a score above 109 in TOEFL iBT or 7.5 in IELTS Academic or equivalent (see Section 3 below).
- GMAT score or GRE score is mandatory for all applicants.

GMAT 10th Edition score of 600 or higher, or GMAT Focus Edition Score of 555 or higher, or GRE score of 160 or higher on Quantitative Reasoning and 150 or higher on Verbal Reasoning.

GMAT scores and GRE Scores are valid for up to five years after the exam date.

*We accept score(s) of GMAT Focus Edition or GRE with shorter overall test time.

(3) Required application documents

All documents must be submitted via the Hitotsubashi ICS Online Application System by the application deadline.

- 1) Please be noted that applications will not be submitted until the applicant clicks the "Submit" button in the bottom of the page of the application system.
- 2) Applicants may start uploading documents once these are available. It is also possible to reupload documentation in the event of you needing to update contents but please note that documentation uploading/re-uploading MUST be done **by the application deadline**.
- 3) Online Application System is accessible only during the application period.
- 4) Only the documents specified in this application package will be reviewed.
- 5) Only complete applications will be screened. If there are any deficiencies, the application cannot be accepted.

(6) Notes for Student Life in Hitotsubashi ICS:

• The annual tuition fee is JPY 642,960, payable in two installments of JPY 321,480 each in October 2025 and May 2026 for AY2025-2026 (preliminary estimate).

The tuition fees above are preliminary estimate. Should the actual amount become subject to revision at the time of admissions or during enrollment, the new revised amount shall be applied and go into effect from the time of revision.

 Please be aware that a health examination taken at the Chiyoda Campus is mandatory for all students newly enrolled at Hitotsubashi ICS in the autumn term of 2026 (except for students who have taken a health examination within one year from October 2025).

Getting to Hitotsubashi ICS by Train

From Takebashi Station

Take the Tokyo Metro (Hanzomon line) or Toei Subway (Shinjuku or Mita lines) to Jimbocho Station. Approximately a threeminute walk from Exit A8.


International Arrival

From Narita Airport

Take the Narita Express train to Tokyo Station (approx. 60 minutes), walk to Otemachi Station (approx. 5 minutes), then take the Tozai line to Takebashi Station. Alternatively, take the Mita line from Otemachi Station to Jimbocho Station.
